Advice from Crime Prevention Officer PC George Ogg

SHED AND COMMERCIAL VEHICLE SECURITY

With summer approaching, this is a good time to consider shed security. Sheds often contain valuable items and following the advice below will help to keep them secure.

- Driveway alarms can be purchased from as little as £12 and can alert homeowners to any persons entering their property. They are easy to install and can be installed in other areas rather than just at driveways.
- Personal attack alarms (about £4) can be utilised as a cost effective but VERY efficient way of alarming a shed, garage or outbuilding.
- Purpose built shed/garage alarms can be bought and installed from as little as £6.
- If alarms are used associated signage should be displayed in a prominent position.
- Installing a PIR (movement detection) light with built in camera offers low cost CCTV and effective lighting. The unit has built in recording equipment so all you need is one unit (no need to purchase a DVD recorder etc) and it retails at under £80.
- There are also a number of padlock alarms on the market. These offer audible protection. If they are cut the circuit is broken and the alarm sounds. Some also sound if they are tampered with. These retail from about £8.
- Use close shackle padlocks so there is very little for the culprits to cut and the haps should be backed onto a metal interior backing plate.
- As previously mentioned re the padlock, metal backing plate's use can be extended and could be installed on the rear of the door and wall of the shed where the fixings are secured through the wood to provide a higher level of substance to the fabric of the building and so better security.
- Every outside door should have three points of locking (top, middle and bottom) with all fixtures and fittings (including hasps and hinges) secured with flat headed bolts security screws or with screws whose heads have been filled in (e.g. with super glue) or "rounded" so they cannot be removed.
- Any windows in the shed should be covered by a blind or a curtain and if light is not a major necessity they should be boarded up.
- **Commercial vehicles** often carry tools and other items that are valuable and attractive to criminals.
- Always secure your vehicle regardless of how long you intend to be away from it. Ensure that your vehicle alarm is fully functional.
- Remove all tools and valuables when leaving the vehicle unattended overnight or for protracted periods of time.
- Never leave the keys in the ignition when away from the vehicle.
- Consider fitting stand - alone alarms to vehicle doors to supplement the vehicle alarm.
- Vibration activated window alarms can be fitted to glass panels.

Elgin – All Wardens

The Wardens dealt with 8 complaints that were all animal related - 4 of them were barking dogs and the other was a cat scaring device that annoyed more than just the moggies. As you will have gathered seagulls accounted for the others.

11 abandoned vehicles were reported in Elgin during May. These enquiries involve a lengthy process of identifying and communicating with the registered keeper of the vehicle if we can. After that has been exhausted and a minimum of 15 days has passed we then arrange for the vehicle to be uplifted for destruction.

In broad terms we treat vehicles as abandoned when they are on land or a road without lawful authority and are clearly not being used. Normally these vehicles may not be taxed, MOT'd or insured. Where we find a vehicle is being used, but may not have required documentation then we liaise with Police Scotland regarding their opportunities for enforcement action.

Wardens have also been working with our colleagues in Trading Standards who have reported that itinerant traders are operating in the area offering a variety of services such as roofing, drive maintenance and garden services. Our advice is not to employ the services of anyone calling at your home offering jobs for cash. The work may well be substandard and overpriced. There will be no guarantee either.

Forres & Upper Speyside – CW Dave Haytack

The month of May has been a busy one in the Forres area starting with a litter pick with the Alves Primary Echo Group contributing to the clean-up of the village resulting in 10 refuse sacks full of rubbish, a few old toys and a bread crate.

The Echo Group will also be delivering leaflets about dog fouling and putting up posters before the end of term.

I gave a presentation to the Coffee Club in Forres Town Hall raising awareness about the role and work of the Community Wardens in Moray.

I engaged with Aberlour Primary 2/3 pupils during a visit to Lynn Woods, Aberlour and was able to encourage them to think about their environment and treat it with respect.

Over the next few weeks I will be working with a student Minister, engaging with youths in the areas they gather especially at Tesco on Nairn Road and also to pass on to them information about activities that may interest them (with food provided!) throughout June at St Leonards Church Hall. Hopefully this will encourage them off the 'street corners'.

Lossiemouth Area – CW Tim Betts

It's the time of year for seagulls again and covering a coastal patch, I receive complaints about householders feeding them. They have started to breed and it will not be long before eggs hatch and parents attend to young gulls. They are extremely protective birds and on occasions this can lead them into conflict with humans. Feeding them, whilst well intentioned, can cause them to be a nuisance and create friction between neighbours especially when gulls are being encouraged into gardens. Whilst it is not against the law to feed seagulls, we strongly encourage people not to do so for the sake of neighbours and gulls alike.

Their noise, mess and swooping behaviour can cause distress and annoyance especially if there is washing out or have newly polished their cars. Gulls are not daft birds and providing food for them encourages them to stay in close proximity, perpetuating the problem.

It is also worth mentioning that 'human' food is bad for the gulls and can significantly reduce their lifespan; gulls' natural diets include shellfish, small sea creatures and insects, not bread and leftovers.

If you are bothered by birds nesting on your property there are some simple measures you can take to prevent this such as installing spikes on landing areas.

Although you can't interfere, kill or injure birds you can employ a properly licensed person to deal with any issues you may be experiencing if the birds have settled on your property.

Seagulls featured a lot this month in the Buckie area as you might expect and the advice given above is very relevant.

However I would like to remind dog owners about their responsibilities. With the fine weather that Moray is currently enjoying there will be an increase in dog owners walking their dogs on the miles of walks Buckie has to offer, but unfortunately this will probably bring an increase in dog fouling complaints.

Dog fouling is not only deeply unpleasant, it is dangerous. Whilst rare, contact with dog excrement can cause toxocariasis – a nasty infection that can lead to dizziness, nausea, asthma and even blindness and seizures.

The Community Safety Team promote the Green Dog Walker Scheme where dog owners are invited to join the scheme and spread the word about responsible dog ownership amongst fellow dog walkers. We will provide the Green Dog Walker merchandise and you can apply by completing this linked form

Keith / Fochabers Area – CW Donna Jamieson

The long summer nights are most welcome especially with some of the nice weather we've enjoyed recently, unfortunately they can also bring noise complaints.

In Keith and Dufftown I dealt with complaints regarding noise from DIY work in a garden, loud music from a barbeque and several about dogs barking. It's great to take advantage of opportunities to get into the garden, but mind the neighbours and mind the clock.

Dog barking is a common complaint throughout Moray and it's usually from animals that are left for extended periods inside or out whilst the owner is at work. Many owners are unaware that their dogs are causing annoyance; the best advice would be to ask your neighbours and if the dog is continually barking there are some great anti-barking devices on the market that curb the noise and don't harm the dogs.

Dog fouling is still an issue in Keith Dufftown & Fochabers and I have installed new signage in Balloch Road and Mid Street, Keith and Tomnamuidh Woods in Dufftown. Strangely these posters were removed by persons unknown the day after installation. Someone with a guilty conscience perhaps?

Both areas have now had replacement signage installed and I wait to see how long they will last.

Forres

4/5 - An unidentified male stole an item of clothing which was on open display at a retail premises in Forres.

Elgin, Heldon, Burghead & Cummington, Lossiemouth, Community Council Area Report

Elgin

Police in Elgin are investigating a break in that occurred overnight 30 April to a building site at Alba Place, Elgin. Tools to the value of £1600 were stolen.

Overnight on 7/8 May a number of thefts and break ins occurred in the Elgin area. These include a tractor broken into whilst parked in the Council Depot at Cooper Park and several building at the building site at Haughs Road entered and tools stolen.

On 12 May a 59 year old male was seriously assaulted on High Street, Elgin. A 35 year old male was arrested and charged with the offence.

Police are investigating a report of fire raising that occurred on 15 May 2017. Circumstances are that a mattress was set alight in a garage on Moray Street causing damage to the garage. Three youths were seen leaving the scene and Police are following a positive line of enquiry.

A 24 year old local male has been arrested and charged in relation to a shed at Kingsmills, Elgin that was broken into. This occurred on 18 May 2017 and a strimmer and lawn mower were stolen.

Tools were again the target when thieves broke into business premises at Tyock Industrial Estate, Elgin overnight 22/23 May 2017.

Lossiemouth

During May 2017 a number of mainly unlocked works vehicles were broken into in Lossiemouth, Fochabers and Lhanbryde and tools stolen. Following information received from members of the public sufficient evidence was gained and a warrant executed at an address in Lhanbryde in relation to these crimes. A 20 year old female was detained, arrested and charged and reported to the Procurator Fiscal in connection with these crimes.

On 6 May 2017 a 51 year old male was seriously assaulted whilst in the Brander Arms, Lossiemouth. A 37 year old male appeared in court from custody, charged with the offence.

Buckie
