4.	Planning, Local Development and	Gary Introduced the local development planning process	
	Community Engagement	He explained that there was a national review of th planning process – there are 4 changes relating to community engagement coming from the review:	
		a) Making plans for the future and to align better special planning with community planning;	
		 b) Gate Check – statutory requirements re engaging community and a gate check process is being introduced to ensure a check on how we intend to engage is proper and fitting; 	
		c) Aligning with locality planning and local place plans to ensure that local development plan reflects aspirations of community in developing place; and	
		d) Involving more people in planning e.g. neighbour notification - would like to involve more people, younger people, link with schools and college and reflect positives that planning brings around housing, green spaces and employment.	

	Emma provided some detail around the steps that it is proposed are taken to take these issues forward locally. There is a communications plan to set out how engagement will take place. Young people are identified as a key group as well as engaging with other new audiences. Looking to make exhibitions interactive and interesting, working with primary and secondary schools using place standards. Also launched a competition for secondary schools to make short films using place standard. Neighbour notifications will generate interest and it is hoped they will come to exhibitions and engage in a more positive discussion.
